The Director of the Idaho Department of Insurance having received an Order from the State of California Department of Insurance wherein the California license of Julie Ann Jordan was revoked, and upon further review having verified the same, the Director does hereby make the following findings and enters a Summary Order as follows:

1. That JULIE ANN JORDAN (JORDAN), of EHealth Insurance Services, Inc. 11919 Foundation Place, Suite 100, Gold River, California, was licensed in California as a producer and that an Order had been entered on or about

October 23, 2009 by the Insurance Commissioner of the State of California effectively revoking JORDAN's California license as of November 22, 2009.

2. That notification of said Order was received by the Idaho Department of Insurance on or about November 24, 2009.
3. That it was learned by the Insurance Commissioner of California that JORDAN had been earlier convicted of a felony involving dishonesty and a breach of trust.
4. That JORDAN has been continuously license as an Idaho non-resident producer since the date of initial issue license on March 5, 2009. The license number, as identified above, is No. 311027.
5. That pursuant to Idaho Code § 41-1016(2) the Director of the Idaho Department of Insurance shall revoke any license issued under Title 41, Chapter 10, Idaho Code where the Director has received a final order of revocation from the insurance regulatory official of the licensee's home state.
6. California is JORDAN's home state and the undersigned Director has received a copy of the Order of Summary Revocation entered by the Insurance Commissioner of the State of California on or about October 23, 2009.
7. Therefore, based upon the foregoing and in consideration of the premises;

IT IS ORDERED that JULIE ANN JORDAN's Idaho non-resident producer license no. 311027 is hereby REVOKED; and


IT IS FURTHER ORDERED that JULIE ANN JORDAN shall immediately surrender and return her non-resident producer license no. 311027 to the Idaho Department of Insurance at

the following address: Idaho Department of Insurance, 700 West State Street, 3rd Floor, Boise, Idaho, 83720-0043.

IT IS SO ORDERED.

NOTIFICATION OF RIGHTS

This constitutes a final order of the agency. Any party may file a motion for reconsideration of this final order within fourteen (14) days of the service date of this order. The agency will dispose of the petition for reconsideration within twenty-one (21) days of its receipt, or the petition will be considered denied by operation of law. *See* Idaho Code § 67-5246(4).

Pursuant to Idaho Code §§ 67-5270 and 67-5272, any party aggrieved by this final order may appeal it by filing a petition for judicial review in the district court of the county in which: (1) the hearing was held; or (2) the final agency action was taken; or (3) the aggrieved party resides or operates its principal place of business in Idaho; or (4) the real property or personal property that was the subject of the agency decision is located. An appeal must be filed within twenty-eight (28) days of: (a) the service date of this final order, or (b) an order denying a petition for reconsideration, or (c) the failure within twenty-one (21) days to grant or deny a petition for reconsideration, whichever is later. *See* Idaho Code § 67-5273.

The filing of a petition for judicial review to the district court does not itself stay the effectiveness or enforcement of the order under appeal.
