The Director of the Idaho Department of Insurance having received an Order from the State of Nevada, Department of Business and Industry, Division of Insurance, wherein the Nevada license of Thomas G. Vail was suspended, and upon further review having verified the same, the Director does hereby make the following findings and enters a Summary Order as follows:

1. That THOMAS G. VAIL (hereinafter "VAIL"), of 452 E. Silverado Ranch, #460, Las Vegas, Nevada, was licensed in Nevada as a producer and that an Order had been entered on or about January 21, 2010, by the Commissioner of

Insurance of the State of Nevada effectively suspending VAIL's Nevada license as of January 21, 2010.


2. That notification of said Order was received by the Idaho Department of Insurance on or about February 3, 2010.
3. That it was learned by the Commissioner of Insurance of the State of Nevada that VAIL had been earlier convicted of a felony involving dishonesty and a breach of trust.
4. That VAIL has been continuously licensed as an Idaho non-resident producer since the date of initial issue license on May 1, 2001. The license number, as identified above, is No. 84355.
5. That pursuant to Idaho Code § 41-1016(2) the Director of the Idaho Department of Insurance may revoke without hearing any license issued under Title 41, Chapter 10, Idaho Code where the Director has received a final order of suspension from the insurance regulatory official of the licensee's home state.
6. Nevada is VAIL's home state, and the undersigned Director has received a copy of the Summary of Proceedings, Findings of Fact, Conclusions of Law, Recommendations of Hearing Officer, and Order of the Commissioner entered by the Commissioner of Insurance of the State of Nevada on or about January 21, 2010.
7. Therefore, based upon the foregoing and in consideration of the premises;

IT IS ORDERED that THOMAS G. VAIL's Idaho non-resident producer license No. 84355 is hereby REVOKED; and

IT IS FURTHER ORDERED that THOMAS G. VAIL shall immediately surrender and return his non-resident producer license No. 84355 to the Idaho Department of Insurance at the following address: Idaho Department of Insurance, 700 West State Street, 3rd Floor, Boise, Idaho, 83720-0043.

IT IS SO ORDERED.

NOTIFICATION OF RIGHTS

This constitutes a final order of the agency. Any party may file a motion for reconsideration of this final order within fourteen (14) days of the service date of this order. The agency will dispose of the petition for reconsideration within twenty-one (21) days of its receipt, or the petition will be considered denied by operation of law. *See* Idaho Code § 67-5246(4).

Pursuant to Idaho Code §§ 67-5270 and 67-5272, any party aggrieved by this final order may appeal it by filing a petition for judicial review in the district court of the county in which: (1) the hearing was held; or (2) the final agency action was taken; or (3) the aggrieved party resides or operates its principal place of business in Idaho; or (4) the real property or personal property that was the subject of the agency decision is located. An appeal must be filed within twenty-eight (28) days of: (a) the service date of this final order, or (b) an order denying a petition for reconsideration, or (c) the failure within twenty-one (21) days to grant or deny a petition for reconsideration, whichever is later. *See* Idaho Code § 67-5273.

The filing of a petition for judicial review to the district court does not itself stay the effectiveness or enforcement of the order under appeal.


