STIPULATION AND ORDER

STIPULATION

COMES NOW the Department of Insurance, State of Idaho (the "Department"), by and through its counsel, Mitchell E. Toryanski, Deputy Attorney General; KIMBERLY JOANN ROSTAD ("ROSTAD"); MICHAEL J. WAY ("WAY"); and MICHAEL RHIANNON BAILBONDS, LLC ("MICHAEL RHIANNON"), by and through WAY, its owner, and hereby stipulate and agree as follows:

1. ROSTAD is a licensed Idaho bail agent, holding Resident Bail Agent License No. 112673, and a licensed insurance producer, holding Resident Producer License No. 50181.

2. WAY is a licensed Idaho bail agent, holding Resident Bail Agent License No. 80018.

3. WAY is sole owner of MICHAEL RHIANNON BAILBONDS, LLC, an Idaho Limited Liability Company and bail surety holding Bail Agency License No. 316076.


4. As a consequence of the licensing status of ROSTAD, WAY, and MICHAEL RHIANNON, they fall within the jurisdiction of the Director of the Idaho Department of Insurance (the "Director") and Title 41 of the Idaho Code.

5. Following the Stipulation and Order between the Department and ROSTAD effective April 3, 2009, WAY agrees to act as sponsor for ROSTAD and assume responsibility for all of ROSTAD's actions in the conduct of insurance business for a period of one year beginning January 8, 2010.

6. WAY, MICHAEL RHIANNON, and ROSTAD agree that all records of ROSTAD's accounts will be subject to Department audits at any time during the period of ROSTAD's sponsorship.

7. The parties agree that the terms of this Stipulation are appropriate and proper under the circumstances set forth in the Stipulation of April 3, 2009, and that they have entered into this Stipulation knowingly, voluntarily, and with full knowledge of any rights they may be waiving thereby. Additionally, the parties hereby waive the right to seek reconsideration and judicial review of the attached order.


