**STIPULATION AND ORDER FOR
REVOCATION OF LICENSE**

STIPULATION

COME NOW the Idaho Department of Insurance (the "Department"), by and through its counsel, Thomas A. Donovan, Deputy Attorney General, Gina McBride, Consumer Services Bureau Chief, and Dale Freeman, Senior Financial Examiner, and SHAUNA LISSA WILSON, an individual, and agree as follows:

1. That SHAUNA LISSA WILSON ("RESPONDENT") is and has been a non-resident bail agent holding license No. 93226 since its issuance on December 19, 2003 (and she was licensed as an agent/producer under license number 65380 since October 26, 1998), and therefore falls within the jurisdiction of the Director of the Idaho Department of Insurance (the

“Director”) and title 41 of the Idaho Code.

2. That on or about August 20, 2009, the Department received a complaint from a party to a bail transaction purportedly with Northwest Bail Bonds, Inc., a corporation believed to have been affiliated with RESPONDENT, the license of which has been inactive since 2007.

3. That the Department sent a letter addressed to RESPONDENT at Northwest Bail Bonds, Inc., at the firm’s address of record in Ketchum, Idaho, on August 28, 2009, via first class mail, requesting information related to the bail transaction. No response was received.

4. That on October 5, 2009, the Department mailed a second letter requesting information about the transaction. One copy of this letter was sent via certified mail to RESPONDENT at her business street address of record in Jackson, Wyoming, and was returned as undeliverable due to no street delivery. Another copy of this letter was sent via certified mail on the same date to RESPONDENT at her mailing address of record with the Department. A return receipt for that letter was signed on or about October 16, 2009. No response was received.

5. That on December 1, 2009, the Department sent via certified mail another request for information addressed to Roger Wilson, the former husband of Respondent, or RESPONDENT at Northwest Bail Bonds, Inc., at the firm’s address of record in Ketchum, Idaho, which was the same as Roger Wilson’s address of record with the Department. A return receipt for that letter was signed on or about December 4, 2009. No response was received.

6. That on February 2, 2010, the Department sent a fax addressed to Roger Wilson and/or RESPONDENT at Northwest Bail Bonds, Inc., to the firm’s fax number of record with the Department, which is the same as Roger Wilson’s fax number of record. No response was received.

7. That on February 5, 2010, the Department sent an email to RESPONDENT

requesting current contact information. An email response was received from RESPONDENT on February 6, 2010, giving her address as the post office box in Ketchum, Idaho, which was the address of record with the Department for Northwest Bail Bonds, Inc., and for Roger Wilson, and giving Roger Wilson's address as a post office box in Carson City, Nevada. Prior to receiving this email, the Department had received no change of address information for RESPONDENT.

8. That on February 12, 2010, the Department sent an email to RESPONDENT, attaching copies of the letters mailed to her in August and December 2009, and asking her to provide the information requested in those letters. No response was received.

9. That on February 16, 2010, the Department sent an email to RESPONDENT asking her to provide a physical address no later than February 26, 2010. No response was received.

10. That, pursuant to Idaho Code § 41-1016(1), the Director may impose an administrative penalty not to exceed One Thousand Dollars (\$1,000) and may revoke the license of an insurance producer if the Director finds that one or more of the causes or violations listed therein exists.

11. That RESPONDENT is in violation of Idaho Code §§ 41-247 and 41-1016(1) for failure to respond to inquiry by the Department and is also in violation of Idaho Code § 41-1008(6) for failing to inform the Department of her change of address.

12. That RESPONDENT's Wyoming resident producer license expired on December 31, 2009, and she therefore no longer meets the qualifications to hold an Idaho non-resident license.

13. That, pursuant to Idaho Code § 41-1016(2), the Director may summarily revoke

the license of an insurance producer whose license is discontinued in the licensee's home state.

14. That, as a consequence of the violations set forth above, sufficient cause exists for, and RESPONDENT agrees to, a revocation of her Non-Resident Bail Agent License No. 93226.

15. That the Department agrees not to seek the imposition of further penalties in connection with the above-described violations.

16. That the parties agree that the terms of this Stipulation are appropriate and proper under the circumstances referenced herein and that they have entered into this Stipulation knowingly, voluntarily, and with full knowledge of any rights they may be waiving thereby. Additionally, the parties hereby waive the right to seek reconsideration and judicial review of the attached order.






