BACKGROUND

(1) On or around August 21, 2011, TAMIR M. QADREE (Qadree) submitted to the State of Idaho, Department of Insurance (Department) an Application for Written Consent to Engage in the Business of Insurance Pursuant to 18. U.S.C. §§ 1033 and 1034 (Section 1033 Application), as a prerequisite for applying to the Department for an insurance producer license.

(2) The Department's Director (Director) reviewed Qadree's application and determined that it was appropriate to deny such application, based on the information then before the Department, and on November 17, 2011, the Director's denial of Qadree's Section 1033 Application was issued and served.

(3) On December 6, 2011, the Department received Qadree's request for a hearing on the Director's denial of his Section 1033 Application. A hearing on the matter before a duly-appointed hearing officer was held on December 21, 2011.

(4) On February 17, 2012, the hearing officer issued his Findings of Fact, Conclusions of Law, and Preliminary Order (Preliminary Order), which concluded that under the facts presented at the hearing, Qadree's Section 1033 Application should have been granted. After reviewing the Preliminary Order, the Director determined that it was appropriate to withdraw the denial of Qadree's Section 1033 Application, which withdrawal was issued by letter dated February 23, 2012. The Director's decision to withdraw the denial of Qadree's Section 1033 Application allowed Qadree to apply for an insurance producer license under title 41, Idaho Code.

(5) On February 25, 2012, the Department received an application for an insurance producer license submitted by Qadree, which application the Department has deemed complete.

ORDER

NOW, THEREFORE, pursuant to Idaho Code § 41-1015(1)(d) and -(2), based on the foregoing, and being fully apprised in the premises,

IT IS HEREBY ORDERED that the public interest will best be served by the Department immediately issuing to Qadree a Temporary Insurance Producer License, which license shall be in effect for a period of one hundred eighty (180) days from the date of issuance.

IT IS FURTHER ORDERED that during the one hundred eighty day (180) period in which such Temporary Insurance Producer License is in effect, Qadree shall not apply for an insurance producer license to the insurance regulatory agency of any other state.

IT IS FURTHER ORDERED that, if Qadree conducts business as an Idaho insurance producer in full compliance with title 41, Idaho Code, during the entire one hundred eighty (180) day period, at the end of such time period, the Temporary Insurance Producer License granted to Qadree by this order shall automatically convert to a permanent Idaho Insurance Producer License, and the restriction in the previous paragraph shall be lifted, allowing Qadree to apply for an insurance producer license in any other state, should he choose to do so.

IT IS SO ORDERED.
