**ORDER GRANTING MOTION and

On May 16, 2022, the Director of the Idaho Department of Insurance ("Director") entered an *Order of Default Revoking Idaho Nonresident Producer License of Jeremy Alma Watson*. On July 27, 2022, the Department filed a (*Corrected*) *Order of Default Revoking Nonresident Producer License of Aaron Reid Andrew* ("Orders of Default").

The Director having reviewed the foregoing and the requirements of Idaho § 41-232(5), finds that good cause exists to set aside the Orders of Default, and allow this matter to proceed on the merits.

Based on the foregoing and in consideration of the premises, and good cause appearing;

IT IS HEREBY ORDERED that the Department's *Motion to Set Aside Orders of Default Revoking Idaho Nonresident Producer License of Jeremy Alma Watson* is GRANTED;

IT IS FURTHER ORDERED that the *Orders of Default Revoking Idaho Nonresident Producer License of Jeremy Alma Watson* entered on May 16, 2022, and July 27, 2022, are VACATED and SET ASIDE; and,

IT IS FURTHER ORDERED that JEREMY ALMA WATSON shall forthwith provide the Department of Insurance with complete and current mailing addresses and contact information including his residential and business mailing addresses, in compliance with Idaho Code§ 41-1008(6).
