**SUMMARY ORDER REVOKING
IDAHO NONRESIDENT
INSURANCE PRODUCER LICENSE**

The Director of the Idaho Department of Insurance (“Director”) has received notice of the entry of an order by the Commissioner of Insurance of the Louisiana Department of Insurance indefinitely suspending Louisiana resident insurance producer license no. 608585 issued to Linda Gagnard (“Gagnard”).¹ Upon review of such order, and pursuant to Idaho Code § 41-1016(2)(a), the Director enters this Summary Order revoking Gagnard’s Idaho Nonresident Insurance Producer License No. 881420.

FINDINGS OF FACT

1. Gagnard, at all times relevant hereto, held a Louisiana resident insurance producer license.
2. On February 10, 2022, the Louisiana Commissioner of Insurance issued a Notice of Suspension Order and Notice of Fine in case Article # 7020 1290 0001 0692 7110, suspending Gagnard’s Louisiana resident insurance producer license based upon findings that Gagnard

violated Louisiana law by: (1) failing to reveal her criminal status when directly questioned about the status on the Louisiana insurance producer application; (2) failing to provide felony conviction documentation and information as required by Louisiana law; and (3) failing to obtain an 18 USC 1033 waiver prior to entering the business of insurance.

3. Gagnard has been licensed as an Idaho nonresident insurance producer under license number 881420 since its issuance on September 23, 2021.

CONCLUSIONS OF LAW

4. Idaho Code § 41-1016(2)(a) provides that the Director shall, without hearing, suspend for not more than 12 months, or shall revoke or refuse to continue any insurance producer license issued under title 41, chapter 10, Idaho Code, where the Director has received a final order of suspension, revocation or refusal to continue issued by the insurance regulatory official or court of jurisdiction of the licensee's home state.

5. The Director finds that the above circumstances justify the revocation of Gagnard's Idaho nonresident insurance producer license, pursuant to Idaho Code § 41-1016(2)(a).

ORDER

NOW, THEREFORE, IT IS ORDERED that Idaho Nonresident Insurance Producer License No. 881420 issued to Gagnard is REVOKED effective immediately.

NOTIFICATION REGARDING REPORTABLE PROCEEDINGS

NOTIFICATION OF RIGHTS

This is a final order of the agency. Any party may file a motion for reconsideration of this final order within 14 days of the service date of this order. The agency will dispose of the motion for reconsideration within 21 days of its receipt, or the motion will be considered denied by operation of law. *See* Idaho Code § 67-5246(4).

Any such motion for reconsideration shall be served on the Director of the Idaho Department of Insurance, addressed as follows:

Pursuant to Idaho Code §§ 67-5270 and 67-5272, any party aggrieved by this final order or orders previously issued in this case may file a petition for judicial review in the district court of the county in which:

- i. A hearing was held;
- ii. The final agency action was taken;
- iii. The party seeking review of the order resides, or operates its principal place of business in Idaho; or

- iv. The real property or personal property that was the subject of the agency action is located.

A petition for judicial review must be filed within 28 days of: (a) the service date of this final order, (b) the service of an order denying motion for reconsideration, or (c) the failure within 21 days to grant or deny a motion for reconsideration, whichever is later. See Idaho Code § 67-5273. The filing of a petition for judicial review does not itself stay the effectiveness or enforcement of the order under appeal. Idaho Code § 67-5274.
