**SUMMARY ORDER REVOKING
IDAHO NONRESIDENT
INSURANCE PRODUCER LICENSE**

The Director of the Idaho Department of Insurance ("Director") has received notice that on July 15, 2022, the Chief Financial Officer for the State of Florida has issued an *Order of Revocation* revoking the individual producer insurance license of Tessa M. Beckner ("Beckner"). Upon reviewing the *Order of Revocation*, and pursuant to Idaho Code § 41-1016(2)(a), the Director enters this Summary Order Revoking Beckner's Idaho Nonresident Producer License No. 716948.

FINDINGS OF FACT

1. Beckner, at all times relevant hereto, was licensed in her home state of Florida as an Individual Resident Producer under license No. P182324.
2. On January 25, 2022, the Florida Department of Financial Services issued an *Administrative Complaint* in Case No. 290774-22AG alleging that Beckner had violated Florida law by pleading nolo contendere to one count of battery on a law enforcement officer, a felony. Beckner was properly served with the Administrative Complaint but failed to respond or Answer the Administrative Complaint or request a proceeding within twenty-one(21) days.
3. On July 15, 2022, the Chief Financial Officer issued an *Order of Revocation* adopting

the violations charged in each count of the Administrative Complaint and revoking Beckner's license.

4. Beckner has been licensed as an Idaho nonresident insurance producer under license number 716948 since its issuance on April 1, 2019.

CONCLUSIONS OF LAW

4. Idaho Code § 41-1016(2)(a) provides that the Director shall, without hearing, suspend for not more than 12 months, or shall revoke or refuse to continue any insurance producer license issued under title 41, chapter 10, Idaho Code, where the Director has received a final order of suspension, revocation, or refusal to continue issued by the insurance regulatory official or court of jurisdiction of the licensee's home state.

5. The Director finds these circumstances justify revoking Beckner's Idaho Nonresident Insurance Producer License, pursuant to Idaho Code § 41-1016(2)(a).

ORDER

NOW, THEREFORE, IT IS ORDERED that Beckner's Idaho Nonresident Insurance Producer License No. 716948 is REVOKED, effective immediately.

NOTIFICATION REGARDING REPORTABLE PROCEEDINGS

This is considered a reportable administrative proceeding. NOTIFICATION OF RIGHTS

This is a final order of the agency. Any party may file a motion for reconsideration of this final order within 14 days of the service date of this order. The agency will dispose of the motion for reconsideration within 21 days of its receipt, or the motion will be considered denied by operation of law. *See* Idaho Code § 67-5246(4).

Pursuant to Idaho Code §§ 67-5270 and 67-5272, any party aggrieved by this final order or orders previously issued in this case may file a petition for judicial review in the district court of the county in which:

- i. A hearing was held;
- ii. The final agency action was taken;
- iii. The party seeking review of the order resides, or operates its principal place of business in Idaho; or
- iv. The real property or personal property that was the subject of the agency action is located.

A petition for judicial review must be filed within 28 days of: (a) the service date of this final order, (b) the service of an order denying motion for reconsideration, or (c) the failure within 21 days to grant or deny a motion for reconsideration, whichever is later. See Idaho Code § 67-5273. The filing of a petition for judicial review does not itself stay the effectiveness or enforcement of the order under appeal. Idaho Code § 67-5274.
