**SUMMARY ORDER REVOKING
IDAHO NONRESIDENT
INSURANCE PRODUCER LICENSE**

The Director of the Idaho Department of Insurance (“Director”) has received notice that the Commonwealth of Virginia, State Corporation Commission (“Commission”), has issued an *Order Revoking License*, revoking the license and voiding all appointments issued under said license of Pichinda Horn Lackey (“Lackey”).

Upon reviewing the *Order Revoking License*, and pursuant to Idaho Code § 41-1016(2)(a), the Director enters this Summary Order Revoking Lackey’s Idaho Nonresident Producer License No. 885681.

FINDINGS OF FACT

1. Lackey, at all times relevant hereto, was licensed in her home state of Virginia as a resident insurance producer under Virginia license number 1263693.

2. On August 12, 2022, the Commission issued a final *Order Revoking License* in Case No. INS-2022-00060. In its order, the Commission found Lackey had violated Virginia law by failing to report an administrative action against her in Pennsylvania within 30 calendar days of the final disposition of that matter. The Commission then evoked Lackey’s Virginia resident insurance

producer license to transact the business of insurance in the Commonwealth of Virginia and voided all appointments issued under that license.

3. Lackey has been licensed as an Idaho nonresident insurance producer under license number 885681 since its issuance on October 8, 2021.

CONCLUSIONS OF LAW

4. Idaho Code § 41-1016(2)(a) provides that the Director shall, without hearing, suspend for not more than 12 months, or shall revoke or refuse to continue any insurance producer license issued under title 41, chapter 10, Idaho Code, where the Director has received a final order of suspension, revocation, or refusal to continue issued by the insurance regulatory official or court of jurisdiction of the licensee's home state.

5. The Director finds these circumstances justify revoking Lackey's Idaho Nonresident Insurance Producer License, pursuant to Idaho Code § 41-1016(2)(a).

ORDER

NOW, THEREFORE, IT IS ORDERED that Lackey's Idaho Nonresident Insurance Producer License No. 885681 is REVOKED, effective immediately.

NOTIFICATION REGARDING REPORTABLE PROCEEDINGS

This is considered a reportable administrative proceeding. Be aware that this proceeding must be disclosed on any license application and must be reported to any and all states in which you hold an insurance license.

NOTIFICATION OF RIGHTS

This is a final order of the agency. Any party may file a motion for reconsideration of this final order within 14 days of the service date of this order. The agency will dispose of the motion for reconsideration within 21 days of its receipt, or the motion will be considered denied by operation of law. *See* Idaho Code § 67-5246(4).

Any such motion for reconsideration shall be served on the Director of the Idaho Department of Insurance, addressed as follows:

Pursuant to Idaho Code §§ 67-5270 and 67-5272, any party aggrieved by this final order or orders previously issued in this case may file a petition for judicial review in the district court of the county in which:

- i. A hearing was held;
- ii. The final agency action was taken;
- iii. The party seeking review of the order resides, or operates its principal place of business in Idaho; or
- iv. The real property or personal property that was the subject of the agency action is located.

A petition for judicial review must be filed within 28 days of: (a) the service date of this final order, (b) the service of an order denying motion for reconsideration, or (c) the failure within 21 days to grant or deny a motion for reconsideration, whichever is later. See Idaho Code § 67-5273. The filing of a petition for judicial review does not itself stay the effectiveness or enforcement of the order under appeal. Idaho Code § 67-5274.
