**SUMMARY ORDER REVOKING  
IDAHO NONRESIDENT  
INSURANCE PRODUCER LICENSE**

The Director of the Idaho Department of Insurance (“Director”) has received notice that the Insurance Commissioner of the State of California (“Commissioner”) issued a *Decision and Order Adopting Proposed Decision*, revoking all California insurance licenses issued to Alan George (“George”). Upon reviewing the *Decision and Order Adopting Proposed Decision*, and pursuant to Idaho Code § 41-1016(2)(a), the Director enters this Summary Order Revoking George’s Idaho Nonresident Producer License No. 15642893.

**FINDINGS OF FACT**

1. George, at all times relevant hereto, was licensed in his home state of California as a resident accident, health agent, and life-only insurance agent under License No. OG87879.
2. On August 5, 2022, the Commissioner issued a *Decision and Order Adopting Proposed Decision* in case OAH No. 2022010799, adopting the Administrative Law Judge’s July 6, 2022, Proposed Decision in case File No. SC202000129, and revoked George’s accident and health agent and life-only agent License No. OG87879. The *Decision and Order Adopting Proposed Decision*

and life-only agent License No. OG87879. The *Decision and Order Adopting Proposed Decision* became a final order on September 4, 2022.

3. The underlying facts leading to the revocation were as follows. In November 2019, George signed and submitted a whole life insurance policy application for a consumer that was deceased. George indicated on the application that he personally met with the consumer and that the consumer was present when he signed the application on the consumer's behalf. George also provided his personal bank account number on the consumer's application. The Administrative Law Judge concluded that it was not in the public interest for George to retain his license and, on July 6, 2022, signed a Proposed Decision for an order revoking George's license.

4. George has been licensed as an Idaho nonresident insurance producer under Nonresident Producer License No. 15642893, (formerly 865755)<sup>1</sup> since its issuance on July 27, 2021.

### **CONCLUSIONS OF LAW**

6. Idaho Code § 41-1016(2)(a) provides that the Director shall, without hearing, revoke for not more than 12 months, or shall revoke or refuse to continue any insurance producer license issued under title 41, chapter 10, Idaho Code, where the Director has received a final order of suspension, revocation, or refusal to continue issued by the insurance regulatory official or court of jurisdiction of the licensee's home state.

7. The Director finds that the above circumstances justify the revocation of George's Idaho nonresident insurance producer license, pursuant to Idaho Code § 41-1016(2)(a).

<sup>1</sup> In September 2022, the Idaho Department of Insurance discontinued issuing separate individual license numbers ("Legacy License ID") and began using the individual's National Producer Number ("NPN") as the Idaho License Number.

## **NOTIFICATION REGARDING REPORTABLE PROCEEDINGS**

## **NOTIFICATION OF RIGHTS**

This is a final order of the agency. Any party may file a motion for reconsideration of this final order within 14 days of the service date of this order. The agency will dispose of the motion for reconsideration within 21 days of its receipt, or the motion will be considered denied by operation of law. *See* Idaho Code § 67-5246(4).

Pursuant to Idaho Code §§ 67-5270 and 67-5272, any party aggrieved by this final order or orders previously issued in this case may file a petition for judicial review in the district court of the county in which:

- i. A hearing was held;
- ii. The final agency action was taken;
- iii. The party seeking review of the order resides, or operates its principal place of business in Idaho; or


iv. The real property or personal property that was the subject of the agency action is located.

A petition for judicial review must be filed within 28 days of: (a) the service date of this final order, (b) the service of an order denying motion for reconsideration, or (c) the failure within 21 days to grant or deny a motion for reconsideration, whichever is later. See Idaho Code § 67-5273. The filing of a petition for judicial review does not itself stay the effectiveness or enforcement of the order under appeal. Idaho Code § 67-5274.
