**SUMMARY ORDER REVOKING  
IDAHO NONRESIDENT  
INSURANCE PRODUCER LICENSE**

The Director of the Idaho Department of Insurance (“Director”) has received notice that Lynn Antoinette Smith (“Smith”) no longer holds a valid license in her home state of Mississippi due to nonrenewal. For the reasons discussed below, the Director enters this Summary Order Revoking Smith’s Idaho Nonresident Producer License No. 8537834.

**FINDINGS OF FACT**

1. Smith was licensed in her home state of Mississippi as a resident bail soliciting agent under Mississippi resident License No. 502744.
2. On April 30, 2022, Smith’s Mississippi license expired. Smith’s license was not renewed within 90 days of its expiration and remains inactive.
3. No notice has been provided to the Idaho Department of Insurance of Smith’s relicensing as a resident in another state.
4. Smith has been licensed as an Idaho nonresident insurance producer since May 7, 2021.

## CONCLUSIONS OF LAW

1. Per Idaho Code § 41-1016(2)(b)(ii), the Director shall, without hearing, suspend for up to 12 months, or revoke or refuse to continue, any license issued to a nonresident under title 41, chapter 10, Idaho Code, if: (1) the nonresident no longer is licensed in their home state because they did not renew their license; (2) the license has remained nonrenewed for more than 90 days after its expiration date; and (3) the Director has not been notified that the nonresident has been relicensed as a resident in another state.

2. These circumstances justify revoking Smith's Idaho Nonresident Insurance Producer License under Idaho Code § 41-1016(2)(b)(ii).

## ORDER

NOW, THEREFORE, IT IS ORDERED that Smith's Idaho Nonresident Insurance Producer License No. 8537834 is REVOKED, effective immediately.

## NOTIFICATION REGARDING REPORTABLE PROCEEDINGS

## NOTIFICATION OF RIGHTS

This is a final order of the agency. Any party may file a motion for reconsideration of this final order within 14 days of the service date of this order. The agency will dispose of the motion for reconsideration within 21 days of its receipt, or the motion will be considered denied by operation of law. *See* Idaho Code § 67-5246(4).

Pursuant to Idaho Code §§ 67-5270 and 67-5272, any party aggrieved by this final order or orders previously issued in this case may file a petition for judicial review in the district court of the county in which:


- i. A hearing was held;
- ii. The final agency action was taken;
- iii. The party seeking review of the order resides, or operates its principal place of business in Idaho; or
- iv. The real property or personal property that was the subject of the agency action is located.

A petition for judicial review must be filed within 28 days of: (a) the service date of this final order, (b) the service of an order denying motion for reconsideration, or (c) the failure within 21 days to grant or deny a motion for reconsideration, whichever is later. See Idaho Code § 67-5273. Filing a petition for judicial review does not, by itself, stay the effectiveness or enforcement of the order under appeal. Idaho Code § 67-5274.
