**SUMMARY ORDER REVOKING  
IDAHO NONRESIDENT  
INSURANCE PRODUCER LICENSE**

The Director of the Idaho Department of Insurance (“Director”) has received a final order in which the Commissioner of Insurance of the Louisiana Department of Insurance (“LDI”) suspended Tristan Stephen Bennett’s (“Bennett”) individual insurance producer license. For the reasons discussed below, the Director enters this Summary Order Revoking Bennett’s Idaho Nonresident Producer License, No. 19271852.

**FINDINGS OF FACT**

1. On August 27, 2019, Bennett was licensed in his home state of Louisiana as an individual insurance producer under Louisiana License No. 828549.
2. On October 10, 2022, the LDI issued a final Cease and Desist Order and Summary Suspension (“Order”) against Bennett. The Order noted that on or about July 13, 2022, Bennett violated Louisiana law by the use of false or misrepresentative facts and information, such as the submission of fraudulent applications as an insurance producer while conducting the business of insurance. Bennett was ordered to cease and desist from conducting the business of insurance in Louisiana and his license was suspended, effective immediately.

3. Bennett has been licensed as an Idaho nonresident insurance producer since May 17, 2021.

### CONCLUSIONS OF LAW

1. Per Idaho Code § 41-1016(2)(a), the Director shall, without hearing, suspend for up to 12 months, or revoke or refuse to continue, any license issued to a nonresident under title 41, chapter 10, Idaho Code, if the Director has received a final order of suspension, revocation, or refusal to continue from the insurance regulatory official or court of jurisdiction of the licensee's home state.

2. These circumstances justify revoking Bennett's Idaho Nonresident Insurance Producer License under Idaho Code § 41-1016(2)(a).

### ORDER

NOW, THEREFORE, IT IS ORDERED that Bennett's Idaho Nonresident Insurance Producer License is REVOKED, effective immediately.

## NOTIFICATION OF RIGHTS

This is a final order of the agency. Any party may file a motion for reconsideration of this final order within 14 days of the service date of this order. The agency will dispose of the motion for reconsideration within 21 days of its receipt, or the motion will be considered denied by operation of law. *See* Idaho Code § 67-5246(4).

Pursuant to Idaho Code §§ 67-5270 and 67-5272, any party aggrieved by this final order or orders previously issued in this case may file a petition for judicial review in the district court of the county in which:


- i. A hearing was held;
- ii. The final agency action was taken;
- iii. The party seeking review of the order resides, or operates its principal place of business in Idaho; or
- iv. The real property or personal property that was the subject of the agency action is located.

A petition for judicial review must be filed within 28 days of: (a) the service date of this final order, (b) the service of an order denying motion for reconsideration, or (c) the failure within 21 days to grant or deny a motion for reconsideration, whichever is later. See Idaho Code § 67-5273. Filing a petition for judicial review does not, by itself, stay the effectiveness or enforcement of the order under appeal. Idaho Code § 67-5274.
