ORDER OF DEFAULT

The Director of the Idaho Department of Insurance previously served Respondent with a Notice of Proposed Default Pursuant to Idaho Code § 67-5242A(1) on August 19, 2026. That order gave Respondent seven days from the date of service to file a written petition with the Director requesting the proposed order be vacated and the grounds relied upon, else a default would issue.

The Director, having received no written petition in response to the Notice of Proposed Default, hereby enters an order of default against Respondent EXPRESS SCRIPTS ADMINISTRATORS LLC (“ESA”). The Director finds that Respondent was lawfully served with

the Verified Complaint and Notice of Right to Hearing and that Respondent has failed to file an answer thereto and failed to request a hearing regarding said Complaint. Having found as a result thereof that ESA has waived its rights regarding the opportunity for hearing, and in consideration of the above,

It is hereby ordered that EXPRESS SCRIPTS ADMINISTRATORS LLC shall pay to the Idaho Department of Insurance an administrative penalty of ten thousand dollars (\$10,000).

NOTIFICATION REGARDING REPORTABLE PROCEEDINGS

NOTIFICATION OF RIGHTS

This is a final order of the agency. Any party may file a motion for reconsideration of this final order within fourteen (14) days of the service date of this order. The agency will dispose of the motion for reconsideration within twenty-one (21) days of its receipt, or the motion will be considered denied by operation of law. *See* Idaho Code § 67-5246(4)

Any such motion for reconsideration shall be served on the Director of the Idaho Department of Insurance, addressed as follows:

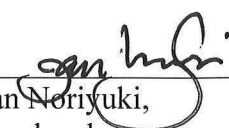
Pursuant to Idaho Code §§ 67-5270 and 67-5272, any party aggrieved by this final order or orders previously issued in this case may file a petition for judicial review in the district court of the county in which: (1) a hearing was held; or (2) the final agency action was taken; or (3) the party seeking review of the order resides or operates its principal place of business in Idaho; or (4) the real property or personal property that was subject of the agency action is located.

A petition for judicial review must be filed within twenty-eight (28) days of: (a) the service date of this final order; or (b) the service date of an order denying motion for reconsideration; (c) the failure within twenty-one (21) days to grant or deny a motion for reconsideration, whichever is later. *See* Idaho Code § 67-5273. The filing of a petition for judicial review does not in itself stay the effectiveness or enforcement of the order under appeal. *See* Idaho Code § 67-5274.
