**STIPULATION & CONSENT ORDER**

The Idaho Department of Insurance ("Department") and Ira Sorensen hereby stipulate:

1. The Director of the Department has jurisdiction over this matter.
2. On December 24, 2014, the Department filed and served a Verified Complaint and Notice of Right to Hearing ("Complaint") on Sorensen.
3. On February 25, 2015, the Department filed and served an Amended Complaint and Notice of Right to Hearing ("Amended Complaint") on Sorensen and his attorney of record.
4. The Amended Complaint alleges that Sorensen entered into a Consent Order with the

state of Utah in May 2014 to settle an administrative action before the Division of Securities of the Department of Commerce of the State of Utah.

5. The Amended Complaint alleges that Sorensen failed to report to the Department within thirty days that he had entered a Consent Order in violation of Idaho Code § 41-1021(1).

6. The parties agree that this matter can be brought to a close by a negotiated and stipulated settlement as opposed to an administrative enforcement action.

7. In settlement of this matter, the parties therefore agree as follows:

- a. That Sorensen admits to Count One of the Amended Complaint, violating of Idaho Code § 41-1021(1), by failing to report the administrative action within thirty days;
- b. That Sorensen will surrender his Idaho Non-Resident Insurance Producer License;
- c. That Sorensen agrees to an administrative penalty of \$200.00;
- d. That Sorensen will not apply for an Idaho Insurance license for a period of five years; and
- e. That the Director of the Idaho Department of Insurance may enter an appropriate Final Order, incorporated herein.

8. Sorensen acknowledges that he has had the opportunity to consult with an attorney of his choice concerning this Stipulation and Consent Order.

9. Sorensen waives his right to notice and hearing, at which he may be represented by counsel, present evidence and examine witnesses.

10. The parties have reviewed and understand the terms and conditions of this Stipulation and Consent Order.

11. The parties agree that the terms of this agreement are appropriate and proper under the

circumstances, and that they entered into this Stipulation voluntarily and with full knowledge of any and all rights they may be waiving.

12. The parties waive the right to seek reconsideration and/or judicial review.

13. The parties agree that the Consent Order will be submitted to the Director of the Idaho Department of Insurance for his review and signature.

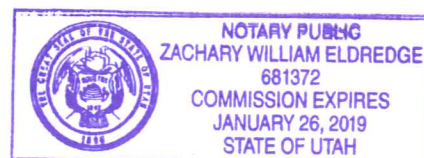

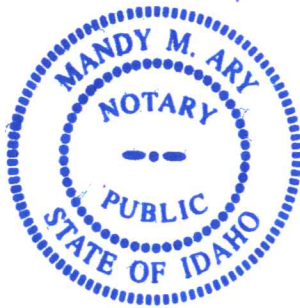
