**ORDER VACATING SUSPENSION
ORDER AND APPOINTING
HEARING OFFICER**

WHEREAS, the Director of the Idaho Department of Insurance (“Director”) entered an *Order Suspending Transaction of Insurance Business in Idaho* (“Suspension Order”) against American Life & Security Corp. (“American Life”), which was filed and served on American Life on April 23, 2015; and

WHEREAS, American Life filed a *Petition for Stay, Clarification, Reconsideration, Modification or Amendment of Order* on May 29, 2015;

IT IS HEREBY ORDERED that the Suspension Order is VACATED.

IT IS FURTHER ORDERED that JEAN R. URANGA is hereby designated and appointed to act as the Hearing Officer in this matter. The Hearing Officer will have the authority and powers to conduct the hearing as provided under title 41, chapter 2, and title 67, chapter 52, Idaho Code, and shall issue a written decision including a Findings of Fact, Conclusions of Law, and a Preliminary Order.

Notice is hereby given that a hearing is to be scheduled at a time convenient to all parties, after all parties herein have been contacted by the appointed hearing officer, whereupon a notice thereof shall be issued accordingly; said hearing to be held at a scheduled time and date in Conference Room A or another conference room of the Idaho Department of Insurance, Joe R. Williams Building, 700 West State Street, 3rd Floor, Boise, Idaho, or such other location as directed by the hearing officer and pursuant to code.

The hearing location designated above meets the requirements of the Americans with Disabilities Act (ADA). Any person requiring assistance of the kind provided by the Department in accordance with the ADA in order to participate in or understand these proceedings should so notify the Department in writing at least five (5) days in advance of the hearing.

The hearing and all preliminary and related matters shall be conducted in accordance with title 41, chapter 2, and title 67, chapter 52, Idaho Code, and the Idaho Rules of Administrative Procedure codified at IDAPA 04.11.01.000 *et seq.*, available at the Idaho State Law Library or which may be purchased from the Idaho Department of Administration (208-332-1820) or obtained via the internet at the Idaho Department of Administration website, which can be found at <http://adminrules.idaho.gov/rules/current/04/index.html>. Inquiries concerning scheduling and hearing facilities should be directed to the Assistant to the Director, Idaho Department of Insurance, P.O. Box 83720, Boise, Idaho 83720-0043, (208) 334-4250.

All further original pleadings, filings, and correspondence in this matter must be filed with the Assistant to the Director at the address above. Copies of all pleadings, filings, and correspondence must also be served upon counsel of record and upon the Hearing Officer at their addresses set forth below.
