**ORDER AUTHORIZING BLOCK
NONRENEWAL**

April 30,
On or about ~~April 30,~~ 2018, the Idaho Department of Insurance (“Department”) received from AETNA LIFE INSURANCE COMPANY (“AETNA LIFE”) a letter notifying the Department that, at the request of AARP, its policyholder, AETNA LIFE intends to discontinue offering and to block nonrenew its grandfathered AARP association group disability plan, including certificates delivered or issued for delivery and providing individual coverage to association members in Idaho, effective as of January 1, 2019. AETNA LIFE represented that the contemplated nonrenewal will affect one (1) certificate holder in Idaho who is provided individual coverage under said plan.

Having reviewed the foregoing and the requirements of Idaho Code §§ 41-2223(1)(i) and 5207(1)(g), and acting pursuant to the authority set forth in Idaho Code § 41-210(2),

THE DIRECTOR HEREBY FINDS that it is in the best interest of the policyholder, AARP, which requested discontinuance of the plan, to permit AETNA LIFE to discontinue and nonrenew its grandfathered AARP association group disability plan.

NOW THEREFORE, IT IS HEREBY ORDERED that AETNA LIFE is authorized, pursuant to Idaho Code §§ 41-2223(1)(i) and 5207(1)(g), to discontinue and effectuate a block nonrenewal of its grandfathered AARP association group disability plan, including certificates delivered or issued for delivery and providing individual coverage to association members in Idaho, effective as of January 1, 2019.

IT IS FURTHER ORDERED that AETNA LIFE shall provide written notice of not less than ninety (90) days to Idaho certificate holders affected by the nonrenewals authorized by this order in accordance with Idaho law and with the notice provisions included in the company's applicable insurance policy.

THIS ORDER is a final order of the Director and is EFFECTIVE IMMEDIATELY.

NOTIFICATION OF RIGHTS

This Order constitutes a final order of the Director. Any party may file a motion for reconsideration of this final order within fourteen (14) days of the service date of this order. The Director will dispose of the petition for reconsideration within twenty-one (21) days of its receipt, or the petition will be considered denied by operation of law. *See*, Idaho Code § 67-5246(4).

Pursuant to Idaho Code §§ 67-5270 and 67-5272, any party aggrieved by this final order may appeal it by filing a petition for judicial review in the district court of the county in which: (1) the hearing was held; or (2) the final agency action was taken; or (3) the aggrieved party resides or operates its principal place of business in Idaho; or (4) the real property or personal property that was the subject of the agency decision is located. An appeal must be filed within twenty-eight (28) days of: (a) the service date of this final order; or (b) an order denying a petition for reconsideration; or (c) the failure within twenty-one (21) days to grant or deny a petition for reconsideration, whichever is later. *See*, Idaho Code § 67-5273. The filing of a petition for judicial review does not itself stay the effectiveness or enforcement of the order under appeal.
