**SUMMARY ORDER REVOKING
IDAHO NONRESIDENT
INDEPENDENT ADJUSTER
LICENSE**

The Director of the Idaho Department of Insurance (“Director”) has received notice of the entry of an order by the Louisiana Commissioner of Insurance, revoking the Louisiana individual claims adjuster license issued to LORIE JEAN ZYLICZ (“ZYLICZ”), as further described below. Upon review of such order, and, pursuant to the authority granted by Idaho Code § 41-1016(2)(a), the Director does hereby make the following findings and enter a Summary Order as follows:

FINDINGS OF FACT

1. ZYLICZ, at all times relevant hereto, was a resident of the state of Louisiana and was licensed by the Louisiana Department of Insurance as a claims adjuster.

2. On or about March 14, 2019, the Louisiana Commissioner of Insurance issued a Notice of Revocation Order, reflecting the revocation of ZYLICZ's Louisiana claims adjuster based on ZYLICZ's failure to report the revocation of her Washington and Oregon insurance adjuster licenses. Such order became effective on or about May 3, 2019.

3. ZYLICZ has been continuously licensed as an Idaho nonresident independent adjuster, holding license number 555269 from the date of the initial issuance of such license on December 11, 2015, to the present date.

CONCLUSIONS OF LAW

4. Chapter 11, title 41, Idaho Code, establishes the qualifications for and scope of adjuster licenses in Idaho. Idaho Code § 41-1108(5) provides that the penalties set forth in section 41-1016, including revocation of licenses, are applicable to adjusters.

5. Idaho Code § 41-1016(2)(a), as incorporated and made applicable by section 41-1108(5), provides that the Director shall, without hearing, suspend for not more than twelve (12) months, or shall revoke or refuse to continue an insurance adjuster license issued under title 41, chapter 11, Idaho Code, where the Director has received a final order of suspension, revocation or refusal to continue issued by the insurance regulatory official or court of jurisdiction of the licensee's home state. Based on the foregoing, the Director finds that the circumstances set forth above justify the revocation of ZYLICZ's Idaho nonresident independent adjuster license, pursuant to Idaho Code §§ 41-1016(2)(a) and 41-1108(5).

ORDER

NOW, THEREFORE, IT IS HEREBY ORDERED that Idaho Independent Adjuster License No. 555269 issued to ZYLICZ is hereby REVOKED effective immediately.

IT IS FURTHER ORDERED, pursuant to Idaho Code § 41-1027(1), that ZYLICZ shall

immediately return Idaho Independent Adjuster License No. 555269 to the Idaho Department of Insurance at the following address: 700 West State Street, P.O. Box 83720, Boise, Idaho, 83720-0043.

NOTIFICATION REGARDING REPORTABLE PROCEEDINGS

This is considered a reportable administrative proceeding. As such, it is a public record and is public information that may be disclosed to other states and reported to companies by which you are actively appointed. This information will be reported to the National Association of Insurance Commissioners (NAIC) and will appear in the Idaho Department of Insurance's online searchable database. Be aware that this proceeding must be disclosed on any license application and must be reported to any and all states in which you hold an insurance license.

NOTIFICATION OF RIGHTS

This is a final order of the agency. Any party may file a motion for reconsideration of this final order within fourteen (14) days of the service date of this order. The agency will dispose of the motion for reconsideration within twenty-one (21) days of its receipt, or the motion will be considered denied by operation of law. *See* Idaho Code § 67-5246(4).

Pursuant to Idaho Code §§ 67-5270 and 67-5272, any party aggrieved by this final order or orders previously issued in this case may file a petition for judicial review in the district court of the county in which:

- i. A hearing was held;
- ii. The final agency action was taken;
- iii. The party seeking review of the order resides, or operates its principal place of business in Idaho; or
- iv. The real property or personal property that was the subject of the agency action is located.

A petition for judicial review must be filed within twenty-eight (28) days of: (a) the service date of this final order, (b) the service of an order denying motion for reconsideration, or (c) the failure within twenty-one (21) days to grant or deny a motion for reconsideration, whichever is later. *See* Idaho Code § 67-5273. The filing of a petition for judicial review does not itself stay the effectiveness or enforcement of the order under appeal. Idaho Code § 67-5274.
