**ORDER SETTING ASIDE THE
ORDER OF DEFAULT AND
GRANTING MOTION FOR
SURRENDER OF LICENSE**

THE DOCKET IN THE ABOVE-ENTITLED MATTER showing that, on April 23, 2019, the Idaho Department of Insurance (“Department”) filed a Verified Complaint and Notice of Right to Hearing and served the same on iVantage Insurance Solutions, LLC (“iVantage”) on the same date; that, upon filing of an Affidavit of counsel on May 15, 2019, demonstrating that iVantage had failed to file an answer within the time allowed by law, the Director entered an Order of Default on May 16, 2019; that thereafter, on May 20, 2019, iVantage filed a notice for the record asserting that it had timely mailed a response to the Verified Complaint, along with a request that the Department accept the voluntary surrender of its Third Party Administrator License No. 667772, and notifying the Department that iVantage had not written any business in Idaho to date; and iVantage having filed a Motion for Reconsideration on May 24, 2019, setting forth its grounds for setting aside the Order of Default therein and renewing its request that iVantage be permitted to surrender its license to the Department, and noting among other things, that iVantage had mailed

its Answer to the Department on May 10, 2019; and the Department having not filed any response thereto; and

Finally, in the interim, the Director having received on May 28, 2019, iVantage's Answer, evidencing thereon and the Director finding that iVantage's Answer had been sent via first class U.S. Mail on May 10, 2019, as asserted; and in consideration of the premises;

IT IS HEREBY ORDERED that the Order of Default is hereby **SET ASIDE**; and,

IT IS FURTHER ORDERED that iVantage Insurance Solutions, LLC, shall surrender its Idaho Third Party Administrator License No. 667772 to the Idaho Department of Insurance no later than thirty (30) days from the date of this Order; otherwise this matter shall proceed to hearing.

IT IS SO ORDERED.
