**ORDER NUNC PRO TUNC
GRANTING THE
PETITIONER'S REQUEST
FOR TERMINATION**

The Petitioner, North Idaho College, having submitted a petition for termination of a self-funded employee health benefit trust operated by the North Idaho College; said termination to be effective June 30, 2020; and the Director having reviewed said request, the Director makes the following findings and conclusions and enters an Order Granting the Petitioner's Request for Termination:

1. The Trust is an unregistered self-funded health care plan subject to Title 41, Chapter 40, Idaho Code, that has been operated on a continuous basis since July 1, 2018. The funds in the Trust are fiduciary funds in accordance with section 41-4008, Idaho Code;
2. On December 6, 2019, the Trust filed with the Director of the Idaho Department of Insurance a request for termination of said Trust in accordance with section 41-4018, Idaho Code,

with an effective date of June 30, 2020;

3. The grounds for termination of said Trust are based on North Idaho College's request for termination filed on December 6, 2019, in accordance with section 41-4018(1), Idaho Code.

4. The Trust shall file with the Department a proposed Plan of Liquidation in accordance with section 41-4019, Idaho Code.

THEREFORE, upon review of the record and in consideration of the premises,

IT IS HEREBY ORDERED that the self-funded employee health benefit trust operated by North Idaho College is hereby TERMINATED effective retroactively to June 30, 2020;

IT IS FURTHER ORDERED that the Trust submit a fair and equitable Plan of Liquidation for approval in accordance with section 41-4019, Idaho Code;

IT IS FURTHER ORDERED that any balance remaining after payment or adequate provision of all claims and charges against the Trust fund shall be disposed in accordance with the approved Plan of Liquidation; and,

IT IS FURTHER ORDERED that the existence of surplus funds for final disposition shall be determined in accordance with section 41-4019, Idaho Code.

IT IS SO ORDERED.
