STIPULATION AND FINAL ORDER AUTHORIZING TRANSACTION OF INSURANCE BUSINESS IN IDAHO

COMES NOW the Idaho Department of Insurance ("Department") and American Life & Security Corp., a Nebraska corporation, holding Idaho Certificate of Authority No. 1695 ("American Life"), and do hereby agree:

BACKGROUND

- 1. American Life is a foreign life and disability insurer domiciled in Nebraska, holding Idaho Certificate of Authority No. 1695 issued by the Director of the Idaho Department of Insurance ("Director"), and is therefore subject to the jurisdiction of the Director pursuant to the Idaho Insurance Code, title 41, Idaho Code.
- 2. On June 30, 2015, the Director issued a Final Order in Docket No. 18-3040-15 approving and adopting a stipulation between the Department and American Life, whereby

American Life agreed that it would not accept new insurance business in the state of Idaho without prior written approval from the Department. American Life further agreed to provide to the Department such financial and other information as the Department might request while the stipulation remained in force. Such stipulation was based on the conclusion by the Department's financial analyst that American Life was in hazardous financial condition, which conclusion American Life disputed.

- 3. American Life has cooperated in providing requested financial information to the Department.
- 4. American Life has requested authorization from the Department to resume the transaction of insurance business in the state of Idaho.

STIPULATION

WHEREFORE, the Department and American Life stipulate as follows:

- 5. Financial information provided by American Life to the Department demonstrates that American Life is no longer in hazardous financial condition as defined in Idaho law and Department rule.
- 6. American Life is allowed to resume the transaction of insurance business, including new insurance business, in the state of Idaho, in accordance with the terms of its Idaho certificate of authority.
- 7. Nothing in this Stipulation limits or waives the authority of the Department or Director under the Idaho Insurance Code to take any appropriate or necessary action including, but not limited to, setting a hearing to address the potential suspension or revocation of American Life's Idaho certificate of authority, in the event American Life's financial condition worsens or in response to any action taken by another state against American Life.

8. By entering into this Stipulation, the parties knowingly and voluntarily waive any

rights they may have to dispute the issues of fact and law raised in the above-entitled matter,

including but not limited to the rights afforded by Idaho Code § 41-232A, which provides for the

right to a hearing, and the right to seek judicial review or appeal the Final Order entered herein.

9. This Stipulation embodies the entire agreement between the Department and

American Life, and there are no agreements, understandings, representations or warranties that

are not expressly set forth herein.

10. This Stipulation is subject to approval by the Director and shall become effective

and binding upon the Department and American Life upon such approval. Should the Director

decline to approve this Stipulation, the Department and American Life shall retain all their rights,

claims and/or defenses, and any factual and/or legal admissions made by the parties herein shall

be withdrawn.

11. The parties have reviewed the proposed Final Order below and agree as to its

form and that said Final Order may be submitted to the Director for his review and signature.

NOTIFICATION OF RIGHTS

This is a final order of the agency. Any party may file a motion for reconsideration of this final order within fourteen (14) days of the service date of this order. The agency will dispose of the motion for reconsideration within twenty-one (21) days of its receipt, or the motion will be considered denied by operation of law. See Idaho Code § 67-5246(4).

Pursuant to Idaho Code §§ 67-5270 and 67-5272, any party aggrieved by this final order or orders previously issued in this case may file a petition for judicial review in the district court of the county in which:

- i. A hearing was held;
- ii. The final agency action was taken;
- iii. The party seeking review of the order resides, or operates its principal place of business in Idaho; or
- iv. The real property or personal property that was the subject of the agency action is located.

A petition for judicial review must be filed within twenty-eight (28) days of: (a) the service date of this final order, (b) the service of an order denying motion for reconsideration, or (c) the failure within twenty-one (21) days to grant or deny a motion for reconsideration, whichever is later. See Idaho Code § 67-5273. The filing of a petition for judicial review does not itself stay the effectiveness or enforcement of the order under appeal. Idaho Code § 67-5274.
