# DOI publishes bulletin and FAQ on business interruption coverage

**BOISE, ID** – Effective April 23, 2020, the Idaho Department of Insurance published <u>Bulletin</u> 20-08 and an <u>FAQ on business interruption coverage</u> in light of COVID-19 in an effort to help answer questions.

Idaho businesses across the state have been negatively impacted by COVID-19. The Department continues to receive questions and concerns about whether business interruption coverage, which can be included in a business owner's policy or commercial package policy, and if coverage extends to businesses that have been closed as a result of the COVID-19 emergency and Stay-Home Order.

<u>Bulletin 20-08</u> provides an overview of this type of coverage as well as the types of policy provisions and exclusions many consumers have questions about. The bulletin also provides guidance to property and casualty carriers and agents about the Department's expectations on how business interruption claims should be handled.

"In addition to <u>Bulletin 20-08</u>, the Department is available to answer questions from these technical and specifically worded provisions of business owners' policies during this very trying situation," said Director Dean Cameron. "We have also created an FAQ page to help proactively provide answers to those questions."
