## **Call to Order:**

Meeting called to order at 9:20am by Chairman Dr. Ted Epperly. A quorum was present.

#### Approval of Minutes from July 8, 2019 meeting:

Meeting began with a discussion of the minutes from the July 8<sup>th</sup> meeting.

## **Financial Report**: as of 8/31/19 (see attached)

Renee' Iverson presented the DOI financial reports.

- As of August 31, 2019, the number of adjustments made to the 2018-2019 Idaho Immunization Assessment survey was 6166 covered lives that have been accepted and/or approved by board action.
- An error was discovered that over estimated covered lives by 5339. This is to be addressed by the board in this meeting.

- National Health Insurance Company has requested an adjustment and refund of assessments paid due to a double reporting of 433 covered lives. Data was requested from NHIC and analyzed. The DOI is confident that the 433 covered lives were double reported, and the refund is justified.
- To date, all payments have been received in full, except for quarterly payment plans.
- There is a discrepancy in fund balances between Department of Insurance and Department of Health & Welfare. DOI reports \$10,976,606 and DHW reports \$10,958,406 a difference of \$18,200. A July payment of \$18,200 was made directly to DHW. DOI is currently working with DHW to track down the discrepancy.
- Forecasted financials are reporting a surplus of \$2,033,330 for the 2018-2019 Idaho Immunization Assessment.
- Kudos to Renee' Iverson. Dr. Epperly, Chairman, is impressed with the clarity of the financial reporting.

Motion to approve current adjustments and NHIC correction made by Hon. Sen. Martin, seconded by Ms. Sinclair. By voice vote, motion to approve adjustments passed unanimously.

Motion to approve financial report as modified made by Dr. Epperly, seconded by Ms. Sinclair. By voice vote, motion to approve adjustments passed unanimously.
