III. Financial Report: as of 10/31/2020 - Reneé Iverson

On the Assessments sheet, page 1, we have 269,758 child lives under 19. Total assessment of \$18,883.060.00. This number includes two requests for reductions.

1. In September, a request from Business Solvers – they do not pay for vaccinations. They are requesting a reduction of 707 from the survey.

2. CareFirst had a miscalculation and have reduced their number from 889 to 80. They are requesting a refund.

Line 38 shows we have received \$4,078,865.00. Line 42 shows the CFA refund of \$56,630.00. One payment not yet paid – Integra 490. Symetra has paid.

Cash Balance, page 2: Line 17, we sent \$2,552,952.50 to Health & Welfare. Total fund is \$11,329,745.00. Line 35, Total Expenditures amount \$8,319,273.43 for a balance of \$9,050,227.45. H Health & Welfare and DOI totals match.

Forecast, Page 3. We have assessments \$745,500 higher than budgeted. That's not unusual.
