## **State Fire Marshal**



• On July 12, 2023, State Fire Marshal Knute Sandahl presented *Maintenance: The Front Line to Fire Prevention* during one of the breakout sessions at the Idaho Health Care Association's annual convention in Boise, Idaho.



A serial arsonist is being sought for several fires in Sandpoint, Idaho. An arrest warrant was
issued for Tony Lee Nash who is suspected of being responsible for these crimes. With the hard
work and collaborative effort by the Sandpoint Police Department and the Idaho State Fire
Marshal's Office, a Bonner County District Judge issued the warrant. The suspect, Tony Lee
Nash, is known to ride on rail cars from state to state.



• The Idaho State Fire Marshal's Office in cooperation with the City of Eagle, Idaho Parks and Recreation, and the Eagle Fire Department provided inspection of the ariel fireworks show at the Eagle Island State Park during Eagle's Fun Days on July 7, 2023. This was an important and lengthy process to ensure visitors to the state park were safe and that the park would not suffer the consequences of a mishap if one should occur. The contractor was checked for proper documentation of training and experience, insurance and bonding, and many other key safety features.
