

ITEM FIRST IGNITED

STRUCTURAL COMPONENT, FINISH

- 11 Exterior roof covering, surface, finished
- 12 Exterior sidewalls, covering, surface, finished
(Includes eaves)
- 13 Exterior trim, appurtenances (Includes doors, porches, and platforms)
- 14 Floor coverings or rug/carpet/met, surfaces
- 15 Interior wall covering (Includes cloth wall coverings, wood paneling, and items permanently affixed to wall or door. Excludes curtains and draperies (use 36) and decorations (use 42))
- 16 Interior ceiling covering or finish (Includes cloth permanently affixed to ceiling and acoustical tile)
- 17 Structural member or framing
- 18 Thermal, acoustical insulation within wall, partition or floor/ceiling space (Includes fibers, batts, boards, loose fills)
- 10 Structural component or finish, other

FURNITURE, UTENSILS (INCLUDES BUILT-INS)

- 21 Upholstered sofa, chair, vehicle seats
- 22 Non-upholstered chairs, bench
- 23 Cabinetry (Includes file cabinets, pianos, dressers, chest of drawers, desks, tables, and bookcases. Excludes TV sets and appliance housing, use 25)
- 24 Ironing board
- 25 Appliance housing or casing
- 26 Household utensils (Includes kitchen and cleaning utensils)
- 20 Furniture, utensils, other

SOFT GOODS, WEARING APPAREL

- 31 Mattress, pillow
- 32 Bedding: blanket, sheet, comforter (Includes heating pads)
- 33 Linen, other than bedding (Includes towels and tablecloths)
- 34 Wearing apparel not on a person
- 35 Wearing apparel on a person
- 36 Curtains, blinds, drapery, tapestry
- 37 Goods not made up (Includes fabrics and yards)
- 38 Luggage
- 30 Soft goods, wearing apparel, other

ADORNMENT, RECREATIONAL MATERIAL, SIGNS

- 41 Christmas trees
- 42 Decorations
- 43 Sign (Includes outdoor signs such as billboards)
- 44 Chips (Includes wood chips)
- 45 Toys, games
- 46 Awning, canopy
- 47 Tarpaulin, tent
- 40 Adornment, recreational materials, signs, other

STORAGE SUPPLIES

- 51 Box, carton, bag, basket, barrel (Includes wastebaskets)
- 52 Material being used to make a product (Includes raw materials used as input to be manufacturing or construction process. Excludes finished products)
- 53 Pallet, skid, empty (Excludes palletized stock, use 58)
- 54 Cord, rope, twine, yarn
- 55 Packing, wrapping, material
- 56 Baled goods or material (Includes baled storage)
- 57 Bulk storage
- 58 Palletized materials, material stored on pallets
- 59 Rolled, wound material (Includes rolled paper and fabrics)
- 50 Storage supplies, other

LIQUIDS, PIPING, FILTERS

- 61 Atomized, vaporized liquid (Includes aerosols)
- 62 Flammable liquid/gas (fuel) in or escaping from combustion engines
- 63 Flammable liquid/gas in or escaping from final container or pipe before engine or burner (Includes piping between the engine and the burner)
- 64 Flammable liquid/gas in or escaping from container or pipe (Excludes engines, burners, and their fuel systems)
- 65 Flammable liquid/gas, uncontained (Includes accelerants)
- 66 Pipe, duct, conduit, hose
- 67 Pipe, duct, conduit, hose coverings (Includes insulated materials whether acoustical or thermal)
- 68 Filter (Includes evaporated cooler pads)
- 60 Liquids, piping, filter, other

ORGANIC MATERIALS

- 71 Agricultural crops (Includes fruits and vegetable)
- 72 Light vegetation, not crop (Includes grass, leaves, needles, chaff, mulch, and compost)
- 73 Heavy vegetation, not crop (Includes trees and brush)
- 74 Animal, living or dead
- 75 Human, living or dead
- 76 Cooking materials (Includes edible material for human or animal. Excludes cooking utensils, use 26)
- 77 Feather or fur not on an animal, but not process into a product.
- 70 Organic, material, other

GENERAL MATERIALS

- 81 Electrical wire, cable insulation. (Do not classify the insulation on the wiring as the item first ignited unless there were no other materials in the immediate area, such as found in a cable tray or electrical vault.)
- 82 Transformer (Includes transformer fluids)
- 83 Conveyor belt, drive belt, V-belt
- 84 Tire
- 85 Railroad ties
- 86 Fence, pole
- 87 Fertilizer
- 88 Pyrotechnics, explosive

GENERAL MATERIALS CONTINUED

- 91 Books
- 92 Magazines, newspaper, writing paper (Includes files)
- 93 Adhesive
- 94 Dust, fiber, line (Includes sawdust and excelsior)
- 95 Film, residue (Includes paint, resin, and chimney film or residue and other films and residues produced as a byproduct of an operation.)
- 96 Rubbish, trash, waste
- 97 Oily rags
- 99 Multiple items first ignited (Use only where there are multiple fires started at approximately the same time on the same property and more than one item was initially involved.)

****Codes ending in '0' (i.e., 10, 20, 30 etc.) should be used ONLY when other codes don't apply.**

*****Use "undetermined" when without a doubt the Item First Ignited cannot be identified.**
