Basic Module

- Alarm, Arrival, and Last Unit Cleared dates/times. If using the Wildland Module, the Controlled Time is required.
- If the latitude and longitude can be pinpointed, enter that information in the Wildland Fire Module instead of entering address/direction. If the fire is on someone's land, us their address and address type when necessary.
- Mutual Aid. Idaho Department of Lands and National Forest, use "Other Aid Given"
- Resources
- Record damage to vegetation, crops, etc. Estimated Dollar Losses & Values are estimates and are required for all fires.
- Property Use:
- 655 Crops/Orchards
- 669 Forest, timberland, woodland
- 931 Open Land or Field

Civilian Fire Casualty Module

Complete if the civilian is in your jurisdiction. Fire departments giving aid is always None. Complete one module for each civilian injured/death)

Fire Service Casualty Module

Completed when an injury, death, or exposure to your own Fire Service Personnel occurs in any incident. One module should be completed for each person if there are multiple injuries, deaths, or exposures.

Arson Module

The Arson Module is only allowed for Incident types: 100 - 173, with the "Fire Cause" field code in the Fire Module being either "1 – Intentional", "5 – Cause under Investigation." If the optional Wildland Module was used in place of the Fire Module, the Wildland Fire Cause must be coded as "7 – Incendiary".
