Welcome New Director

Dean Cameron was appointed by Governor C.L. "Butch" Otter to serve as Director of the Idaho Department of Insurance effective June 15, 2015. Director Cameron is

a third generation insurance agent and has 24 years of experience in state government.

Director Cameron was a partner in Cameron and Seamons Insurance and Investments since 2004 and a partner in Cameron and Cameron Insurance Benefit Designers from 1989 to 2004.

Director Cameron served 13 terms in the state senate, including eight terms as Chair of the Senate Finance Committee and Co-chair of JFAC, the state's budget committee. At the time of his appointment, he was the most senior member of the Senate.

STATE FIRE MARSHAL

Fire in Idaho

In June, the State Fire Marshal's Office (SFM) conducted 48 inspections, 28 plan reviews and 12 fire investigations.

The Reid Hatley Industries fire on June 16 in Hayden resulted in several million dollars in property loss.

Although this fire is still under investigation, it has been ruled an arson.

The Idaho City Fire on June 5 resulted in the total destruction of five businesses. This fire also remains under investigation.

Digitizing of all sprinkler plans continues. This project will allow the SFM to retrieve sprinkler plans at a moment's notice eliminating the cost for storage. Plans are required to be kept for the life of a building per section 104.6 of the Idaho Fire Code.


PRODUCER LICENSING

New CE Rule

As of April 11, 2015, resident independent adjusters are required to complete 24 hours of continuing education, including three hours of ethics. This new rule brings Idaho in line with national licensing standards.

The Insurance License Exam Review Committee – including members of the Licensing and Consumer Affairs Sections – met to review content outline, rate and edit examination questions, and submit new examination questions for the Idaho Producer License examinations.

COMPANY ACTIVITIES

The Company Activities Bureau has been attending training on exam and analysis procedures, new model laws and cyber security.
